 permission application will be returned unapproved if the amount are
 not paid within the stipulated time.

On receipt of the amount, the approved plans will be
 sent to the Commissioner/Executive Officer St Thomas mount
 Township/Town Panchayat/Panchayat Union/Municipality for further
 action.
