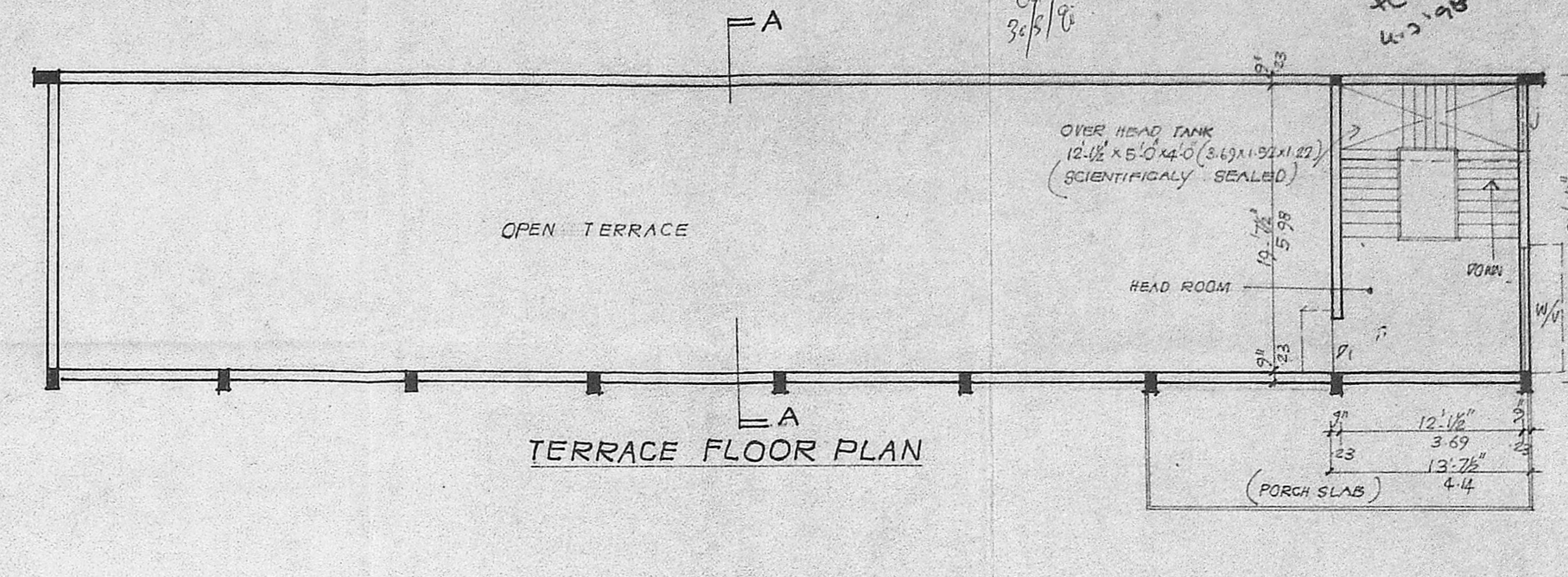

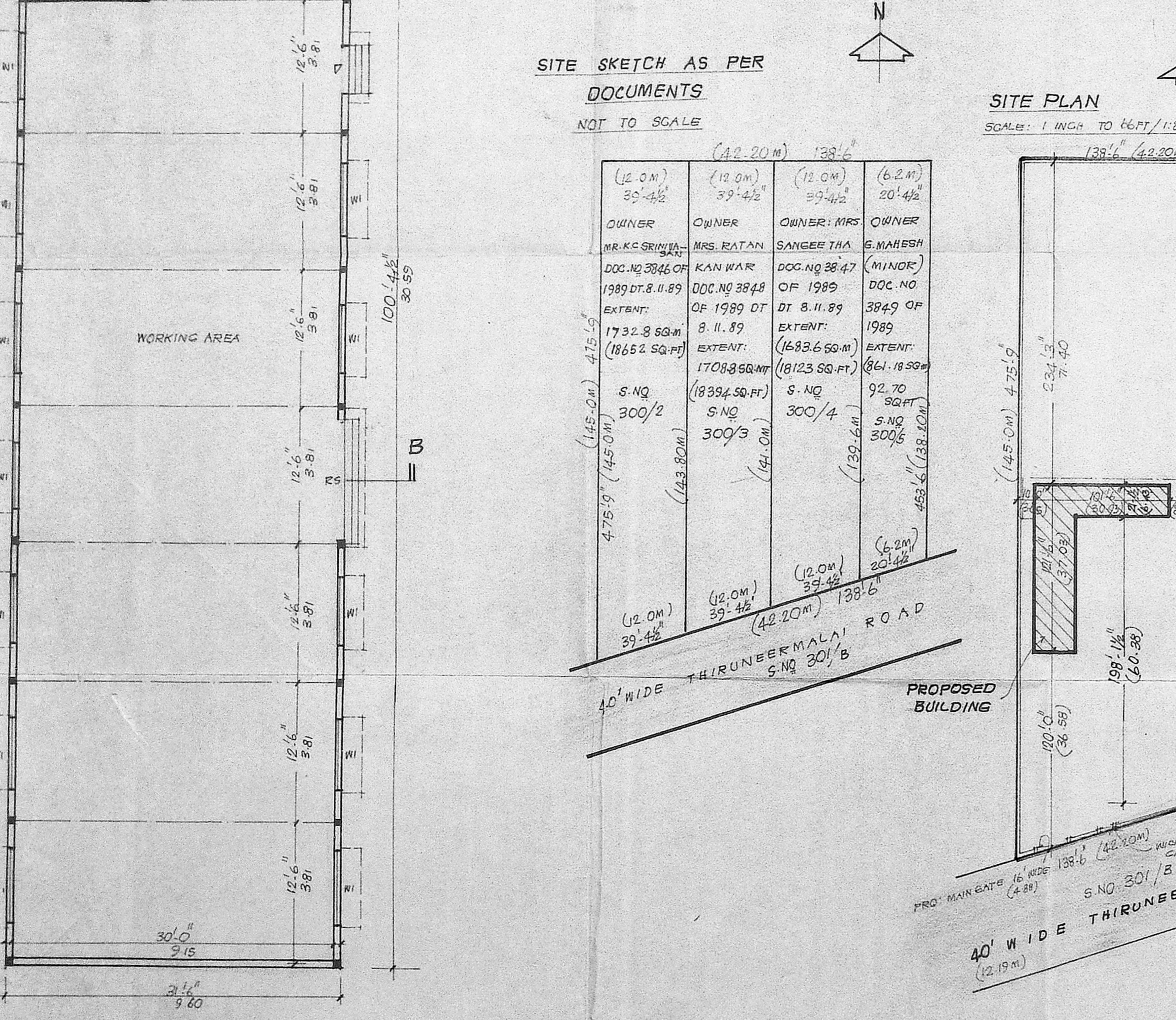

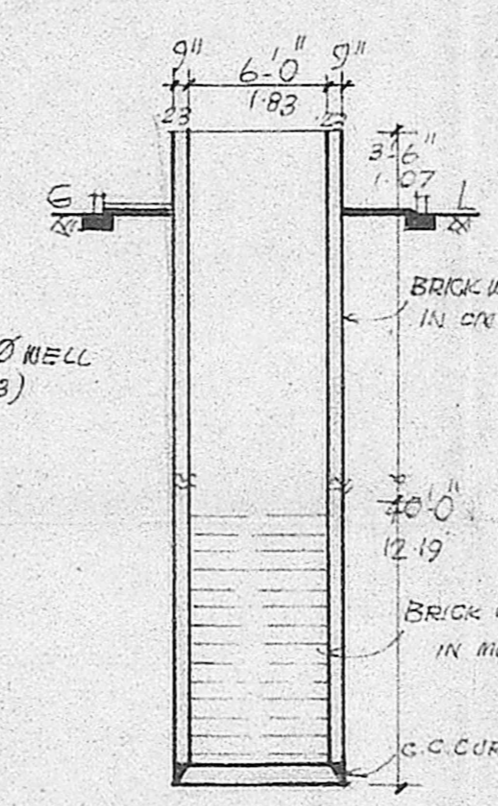
SITE SKETCH AS PER DOCUMENTS  
NOT TO SCALE



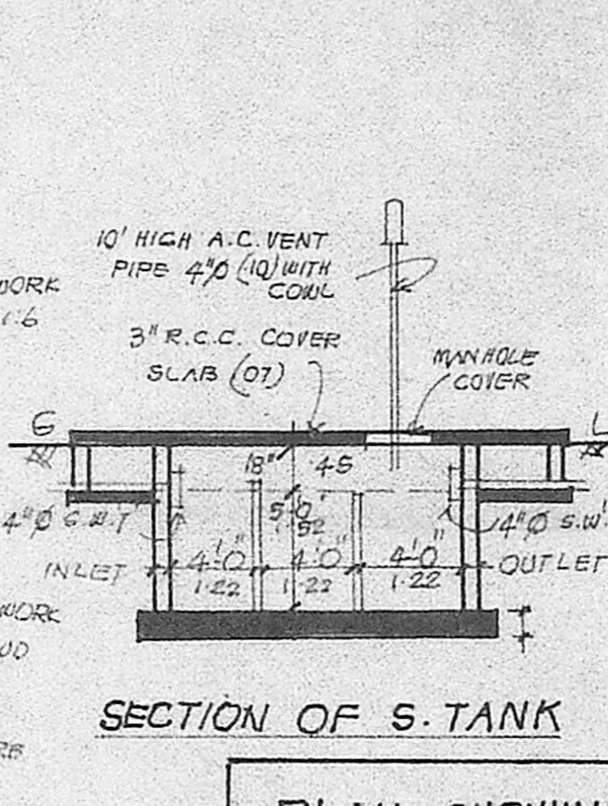
TERRACE FLOOR PLAN



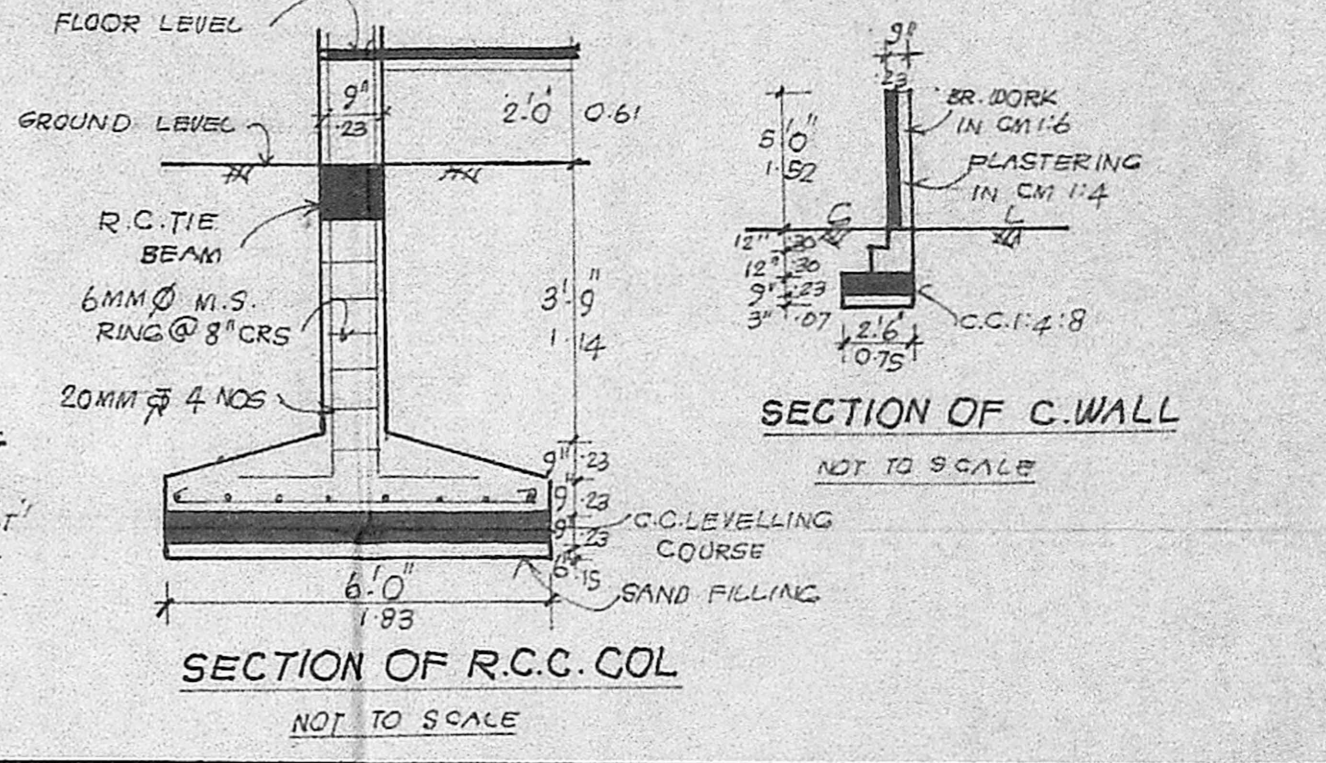
SITE PLAN
