Minutes Non-official members expressed concern that before the promulgation of Tamil Nadu Ordinance No.6 of 2012 on 16.07.2012, the issue was not consulted in the Monitoring Committee meeting. Earlier Tamil Nadu Government informed the Supreme Court that Regularisation Scheme is one time affair with the cut-off date 28.02.1999. Whereas, now the Government have promulgated the Ordinance to exempt the buildings developed on or before 01.07.2007. The non-official members expressed that this Ordinance may not help in preventing deviated/unauthorized developments and may be against taking enforcement activities on deviated/unauthorized buildings.

> It was explained that the Government appointed Justice Mohan Committee in G.O.Ms.No.190, H & UD Dept., dated 1.6.2007. Scope of the Committee was to go into various aspects of Tamil Nadu Town and Country Planning Act 1971 and to suggest modification, amendments and improvements to the Tamil Nadu Town and Country Planning Act,

1971. After detailed deliberations and consultations, the Justice Mohan Committee submitted the report during July 2010 to the Government regarding the review of Tamil Nadu Town and Country Planning Act 1971. Some of the recommendations of Justice Mohan Committee like locking and sealing provisions and levy of infrastructure and amenity charges have already been introduced in the Tamil Nadu Town and Country Planning Act by way of amendments.

It was also explained that the High Court in order dated 04.06.2012 in W.P. No.20618/2010, W.P.No.23936/2010 and W.P.No.3885/2010 etc., passed orders that ".....If there is delay in placing the Bill before the Assembly, the Government may come out with an Ordinance. We, therefore allow six weeks time to enable the Government to come out with the final amendments in respect of the aforesaid Act. Needless to say that the amendments, which are to be brought into force, shall be subject to the judicial review by this Court......"

Accordingly, the Tamil Nadu Ordinance No.6 of 2012 was promulgated on 16.7.2012 by the Government.

Further it was explained that the Sec.113-C newly inserted, though exempt any building developed on or before 01.07.2007, specific guidelines have to be made and it will not be blanket relief to the violations but providing only limited solution to developments such as, FSI violation shall not exceed 50% of the allowable limit and extent of violation in respect of minimum road width required shall not exceed 20%. Activity in the building shall be in conformity to the land use zoning, parking as per standards prescribed in the Development Control Rules shall be made available within the premises under reference or in the vicinity not exceeding a distance of 250 metres from the site under ref. and adequate fire safety measures should have been taken etc., Further it was explained that Rules have not come into force on the Sec.113-C and this Ordinance will not interfere with the Reg. Scheme applications and also under Building Regularisation Scheme the buildings completed on or before 28.02.1999 only are regularisable and all cases rejected by the Monitoring Committee have been rejected and not even in single case the cut-off date 28.02.1999 was exempted.

The non-official members are of the view that this cut-off date 01.07.2007 prescribed in the Tamil Nadu Ordinance 6 of 2012 clashes with the cut off date 28.02.1999 prescribed in the High Court orders dated 23.08.2006. The non-official members expressed concern and have promised to convey their views shortly.
