GENERAL:

The general issues discussed and the decisions arrived at are as given below:-

1) Experts from National Fire Service College, Nagpur and other organizations may be invited for a discussion with the CMDA & DF&RS officials within 15 days to work out suitable alternate fire safety measures that are practical and technologically feasible to provide fire safety measures within the building based upon advancements in the field of fire safety. Examples of fire safety in buildings in other advanced countries having fire safety in buildings predominantly through installation of fire safety equipments and measures within the building may be examined. Most advanced countries do not insist on large set back areas even for Multistoried Buildings, but ensure fire safety in buildings through internal fire safety arrangements. CMDA to make necessary arrangements.

2) An expert committee comprising Fire and Life Safety experts may be formed immediately so as to closely monitor the buildings which are non-fire safety compliant.

3) The Legal Cell of CMDA to furnish a status report on the action to be taken against violated buildings in the light of various court orders issued at various points of time.

4) With regard to proposing locations for developing multilevel car parking, the Commissioner, Greater Chennai Corporation stated that he will come out with suitable proposals during the next meeting

5) The Committee suggested that a 'Corpus Fund' may be created with the OSR charges collected and equal contribution from corporates, group of commercial buildings / organizations, NGOs etc., to provide multilevel car parking complexes.

6) With regard to installing community fire hydrants at vantage points, the DF&RS informed that he would come out with a report on this during the next Monitoring Committee meeting.
